CMC_08_25 Ensuring robust, transparent and objective qualification criteria in the Capacity Market T-4 29/30 auction :GNI note the proposal seeks to include proposed changes to the CMC for the T-4 29/30 auction. Give the relative imminency of qualification timelines in September following a potential decision for the proposed Code Mod (which we understand is August timeline) we do not consider that it is feasible or prudent to apply the requirement for developer to be in receipt of a contract or quotation for a gas connection in the intervening time. We would instead suggest that the proposal would be applicable to the following and subsequent auctions (i.e. T-3 30/21 and thereafter). Due to the high participation rates in the auction process which necessitates a significant number of quotations for complex projects we would also propose that developer apply to GNI for a quotation six months in advance of the qualification timeline to ensure sufficient time to undertake the relevant analysis, designs, estimations, and approvals.
