1. Approval and Adoption of the Agenda

2. Approval of Minutes from Meeting 96 on 27 August 2015

The minutes of meeting 97 on 27 September 2015 were approved subject to minor amendments.

Decision Items

3. CRM Decision Paper 1

The SEM Committee noted the importance of developing the new CRM in a timely manner, given that given that the current CPM is under review by the European Commission. The CRM project team provided an overview of the CRM Decision Paper 1. The project team summarised responses and the SEMC discussed in detail four key issues:

- Administered Scarcity Price;
- Market Reference Price;
- Demand Side Units:
- Socialisation of RO Difference Payment;

The Committee provided input for the further development of the CRM Decision Paper 1, which will be considered at SEMC 100 on 14 December 2015.

4. CPM Ex Post, Fixed and Variable Proportions Decision Paper

PB provided a summary of the paper and noted that no responses had been received. The SEMC endorsed and approved the Decision Paper.

5. DS3 Project Update

ROR provided an update on RoCoF in Northern Ireland. ROR further noted that a Quarterly Update on DS3 would be published in a matter of weeks. He also informed the Committee that the Tariffs Paper was to be approved shortly and noted that an interim tariffs implementation plan was coming to the RAs for approval shortly from the TSOs. The Committee welcomed the interaction between the CRM and DS3 teams. DS3 and CRM teams to present to SEMC at SEMC 99 on issues arising from interaction between the workstreams.

6. F&L Emerging Thinking

JC provided an outline of emerging thinking with respect to consultation responses regarding FTRs, which was noted by SEM Committee.

7. EIL Certification Update

ROR provided an update on the EIL Certification which will commence in January 2016, with a submission to the European Commission by June 2016. The update was noted by the Committee.

8. I-SEM Project Update

JMcA provided an update on the I-SEM project highlighting red, amber and green status of workstreams, which were duly noted by the Committee. JMcA undertook to streamline RAG requirements going forward in the interest of transparency. JMcA noted that six change requests had been logged which were due to be closed in a matter of weeks. An update on stakeholder engagement was also provided.

9. **SEM Communications Strategy**

GI provided a progress update on the SEM Communications Strategy focusing on increasing awareness; enhancing transparency; and promoting engagement. The SEMC was asked to:
