## 6. DS3/ CRM "Strawman" Briefing

ROR provided an overview of the DS3-CRM "Strawman". The SEM Committee noted the contents and discussed at length issues relating to alignment with CRM. The SEM Committee endorsed the approach that is set out in the DS3-CRM "Strawman" paper.

### 7. DS3 Project Update

ROR provided a detailed update on the development of the DS3 project. The Scalar Consultation paper is due to be published in the coming days.

### 8. DS3 Interim Tariffs Update

There was a general discussion around the tariff strategy. A request was sent to the TSO's to provide further clarity on its methodology on the interim tariffs and to provide estimates of the benefits of its SNSP trial. A strong steer was given from the SEM Committee to ensure that 2016 tariffs are set at an appropriate level to optimise the system services benefits over the period to 2020. Final approval on the Consultation Paper is delegated to Project Board.

#### 9. DS3 Contract Design and Qualification

MC gave an outline of the main issues consulted on in the DS3 Contract Design and Qualification Process paper. MC also provided an overview of the responses received and the areas needing attention in the development of a decision paper. Of key importance was the need to ensure alignment and consistency with CRM decisions where this is appropriate and provides benefit to market participants. The SEMC agreed that alignment between CRM and DS3 is important and should be focused on.

### 10. DS3 Capital Budget request for DS3 Systems Services Implementation

ROR provided information to SEM Committee in advance of a detailed budget submission to the DS3 Project Board,
