1. INTRODUCTION

1.1 Background and Purpose

This Agreed Procedure supplements the rules set out in the Capacity Market Code (hereinafter referred as the "Code") in relation to the Qualification Processes administered by the System Operators. It sets out procedures with which Parties to the Code must comply.

1.2 Scope of Agreed Procedure

Part A of this Agreed Procedure sets out the procedures in relation to the Qualification Process in particular:

- (a) Pre-qualification activities;
- (b) Application for Qualification;
- (c) Processing of Applications for Qualification;
- (d) Qualification results; and
- (e) Qualification related procedures.

Part B of this Agreed Procedure sets out the procedures in relation to the Capacity Auction process including pre-Capacity Auction and post-Capacity Auction activities.

This Agreed Procedure forms an annex to, and is governed by the Code. It sets out procedures to be followed, subject to the rights and obligations of Parties under the Code. In the event of any conflict between a Party's obligations set out in the Code and this Agreed Procedure, the Code shall take precedence.

In relation to Part A it is not intended that there be any inconsistency or conflict between section 2 "Overview" and section 3 "Procedural Steps". However, in the event of any inconsistency or conflict, section 3 "Procedural Steps" shall take precedence.

In relation to Part B, it is not intended that there be any inconsistency or conflict between section 4 "Overview" and section 5 "Procedural Steps". However, in the event of any inconsistency or conflict, section 5 "Procedural Steps" shall take precedence.

In section 3 "Procedural Steps" and section 5 "Procedural Steps" a corresponding process flow diagram is included for each procedural steps table. Process flow diagrams are for illustrative purposes. It is not intended that there be any inconsistency or conflict between any procedural steps table and process flow diagram however, in the event of any inconsistency or conflict, a procedural steps table shall take precedence.

1.3 Definitions

Words and expressions defined in the Code shall, unless the context otherwise requires or unless otherwise defined herein, have the same meanings when used in this Agreed Procedure.

References to particular sections relate internally to this Agreed Procedure unless specifically noted.

1.4 Compliance with Agreed Procedure

Compliance with this Agreed Procedure is required under the terms as set out in the Code.

Part A Qualification Process

2. OVERVIEW

2.1 Qualification Process

The Qualification Process under the Code consists of a number of stages as set out below. The procedural steps to be followed in the Qualification Process are set out in section 3 below.



Pre Qualification Activities

 Actions which need to initiated by Participants such as Opting Out or the adjustment of the Unit Specific Price Cap need to be processed prior to Qualification



Qualification Submission

• Submission of all relevant Qualification Information to be provided by Participants'.



Qualification Assessment

•The System Operators evaluates the participant's submission and determines a unit qualification value based on regulatory approved parameters.



Qualification Results

•The outcome of each application will be delivered to Applicants, and made available via the Capacity Market Register, on Qualification Results Day.

2.2 Key Qualification Dates

Qualification Process milestone dates are summarised below. Any timelines given are provisional and these dates are approved by the Regulatory Authorities and may vary for each auction. Key dates in the Qualification Process include:

Exception Application Date: The last time a Participant can apply to the Regulatory Authorities for either a Unit Specific Price Cap in respect of a Capacity Market Unit; or cost recovery beyond the New Capacity Investment Threshold for New Capacity. Note that the Exception Application Date and Opt-out Notification Date may not occur in the exact sequence as illustrated above.

Opt-out Notification Date: The last date a Participant can submit an Opt-out Notification.

Capacity Auction Information Pack Date: The last publication date for the Auction Information Pack.

Qualification Application Date: The last date a Participant can submit an Application for Qualification in respect of a Capacity Year.

Provisional Qualification Submission Date: The date by which the System Operators are expected to provide provisional Qualification results in respect of a Capacity Year to the Regulatory Authorities for approval.

Provisional Qualification Results Date: The date by which the System Operators are expected to inform persons who submit Applications for Qualification of Provisional Qualification Results in respect of a Capacity Year.

Provisional Qualification Review Date: The last date a person who submits an Application for Qualification can apply to the System Operators for a review in respect of Qualification for a Capacity Year.

Final Qualification Submission Date: The date by which the System Operators are expected to provide Final Qualification Results in respect of a Capacity Year to the Regulatory Authorities for approval.

Final Qualification Results Date: The date by which the System Operators are expected to inform persons who submit Applications for Qualification of Final Qualification Results in respect of a Capacity Year.

Qualification Results Publication Date: The date by which the System Operators are expected to publish the total qualified capacity in respect of a Capacity Year. This last date may be earlier in the schedule as shown but it is placed as late as possible to facilitate resolution of reviews and disputes.





Note this process requires interaction and engagement with the Regulatory Authorities and an approval is required prior to the Exception Application Date specified in the Capacity Auction Timetable. Information on cost recovery beyond the New Capacity Investment Rate Threshold can be found in section E.5 and section E.7.5 of the Code.






3.1.4 Opt-out Notification

An Opt-out Notification is a notification provided by a Participant to the System Operators that a Generator Unit or Interconnector of that Participant shall not be included in an Application for Qualification in respect of a Capacity Auction. The rules in relation to Opt-out Notifications are set out in section E.3 of the Code.





3.3 Qualification Assessment



Having received qualification data, the System Operators shall run the qualification calculation process to determine how many MW of each Capacity Market Unit has Qualified. The System Operators must assess applications for qualification in respect of a Capacity Market Unit and apply the rules in approving Existing Capacity and New Capacity as Qualified and for setting the Final De-rating Factors and Maximum Capacity Durations in respect of Existing Capacity and New Capacity that has qualified. The Qualification Calculations are contained in section E.8 of the Code

The high level qualification calculation steps are illustrated in the diagram below.



3.4 Notification of Qualification Decisions

The Qualification Information Results will contain the information outlined Section E.9.1 of the Code.




3.5 Other Qualification Related Process

3.5.1 Extended Qualification for Secondary Trade - Early Start

Secondary trading allows a Participant for a Capacity Market Unit that is undergoing an outage, to purchase a Product through a Secondary Trade Auction that will allow it to offset Awarded Capacity in respect of a Capacity Market Unit, with another Capacity Market Unit providing replacement capacity in its place. The buyer of a Secondary Trade is effectively offsetting the capacity it has "sold" previously, and the seller of a Secondary Trade takes on the obligation to provide the capacity traded.

Where Existing Capacity has been Qualified in respect of a Capacity Year (or "Qualified Year") a Participant may apply to the System Operators to have the start date for Qualification modified so as to commence at a specified date in the prior Capacity Year (called the "Prior Year") for the purposes of allowing the relevant Capacity Market Unit to participate in Secondary Trade Auctions from that earlier date.




3.5.2 Extended Qualification for Secondary Trade – Extended Duration

Where Existing Capacity has been Qualified in respect of a Capacity Year (called the "Qualified Year") and the relevant Participant intends to Close the relevant Capacity Market Unit during the following Capacity Year (called the "Following Year"), the Participant may apply to the System Operators to have the end date for Qualification modified so as to end at a specified Closing date in the Following Year for the purposes of allowing the relevant Capacity Market Unit to participate in Secondary Trade Auctions until that specified Closing date.

For the avoidance of doubt, any extension of Qualified status to apply in the Prior Year or Following Year will allow participation of that Capacity Market Unit in Secondary Trade Auctions but does not allow participation in any Capacity Auction.



3.6 The Alternative Qualification Process

Section E.7.8 of the Code outlines the steps that the System Operators are required to follow to determine the Qualification Results for a Capacity Market Unit using the Alternative Qualification Process.

Where the System Operators are required to determine Qualification results for a Capacity Market Unit using the Alternative Qualification Process, they shall apply the principles outlined in section E.7.8.1 of the Code

In determining the Gross De-Rated Capacity (Existing) and Gross De-Rated Capacity (New) of the Capacity Market Unit, the System Operators shall use the methodology set out in sections E.8.2 and E.8.3 of the Code.

4. OVERVIEW

4.1 Capacity Auction Process

The System Operators are responsible for discharging the auctioneer function as set out in the Code and offer support to Participants during the Capacity Auction process. The procedures outlined in this document consist of a number of Pre-Auction and Post-Auction steps that inform the Participant of the Capacity Auction timelines, data requirements and the Auction Results publication process.






5.2.2 Participant Auction System Access and Offer Submissions


A Participant offering quantities into a Capacity Auction must use the Capacity Market Platform and comply with any procedures issued by the System Operators for using the Capacity Market Platform.

The Auction shall be conducted over the internet. This will allow Authorised Persons to participate in the Capacity Auction from their normal office locations. Bidders shall use the Capacity Market Interface from their own secure client computer connected to the internet, using a browser.


