## RE: Application for derogation as allowed under section G.1.2.3 of the Trading Settlement Code

Dear Colin, John,

Further to the SEMO derogation request SEM-21-091 and your subsequent decision SEM-21-092 of 17 November 2021, SEMO is seeking a derogation as allowed under Section G.1.2.3 of the Trading and Settlement Code. This derogation is in relation to the Demand Side Unit Energy Adjustment Payment or Charge (CEADSU), and potentially related changes arising from the impliementation of Mod\_17\_19, where the application of such payments or charges would result in Demand Side Units (DSUs) incurring undue payments or charges associated with the high price events between 12 August 2021 and 29 September 2021 that would not have occurred if Mod\_02\_21 was effective in the market systems. SEMO is of the view that the rationale set out in SEM-21-091, which satisfied the criteria set down in Section G.1.2.3 of the Trading and Settlement Code, equally applies to these charges.

If Mod 02 21, which sets a flag for interconnector actions and was approved on 12 August 2021, had been effective in the market systems during the high price events there would have been no Reliability Option events during the period. CEADSU was introduced to the Trading and Settlement Code through Mod\_17\_19. However Mod\_17\_19 related payments and charges have not yet been invoiced due to a defect in the system. The fix to address this has since been delivered in Release H in November 2021.
